The Earnest money deposits should be taken only after the date of publishing of NIT and any tender submitted with Earnest Money Deposits drawn before the date of publishing of NIT will be rejected. **The Tender Cost / Earnest money deposit shall be drawn in favour of Accounts officer SDSC SHAR.**

Tenders will be opened at 15.00 Hrs onwards on the date of receipt mentioned above in the presence of attending tenderers or their authorized representatives. The Department reserves the right to reject any or all tenders or to allot parts of the work to different agencies without assigning any reason thereof. Conditional Offers will not be accepted. If any tenderer withdraws his tender after the price bid is opened within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the Government shall without prejudice to any/or other right or remedy be at liberty to forfeit 50% (Fifty percent) of the earnest money absolutely. **Apart from all statutory license/ permissions, the contractor shall obtain "Workmens compensation (General) Insurance policy" for a minimum of 10 number of Labour working in the site. This shall be strictly adhered to.**
